### **What is a Personal Injury?**

Personal injuries are any injury caused by the negligence of another. Negligence where someone fails to act as any reasonable person would in the same situation.

Preventable or not, personal injury accidents are caused by carelessness. That's why victims of negligence can seek funds to cover their pain, suffering, and medical expenses.

There are a number of things you can receive compensation for after an accident. It depends on the details surrounding your injury but, in general, victims receive compensation for:

- Lost wages
- Disability
- Loss of future earning abilities
- Emotional distress
- Disfigurement/mutilation
- Therapy costs
- Medical treatment
- Funeral costs
- Wrongful death



# WORKER'S COMPENSATION

Everyone knows that workers get hurt on the job, and we have a system of workers' compensation to help those injured in workplace accidents. But did you know that:

- You don't have to be at your job site for your injury to qualify.
- Getting sick from chemical exposure qualifies as an injury.
- You can choose your own doctor.

There are many twists and turns in Louisiana workers' compensation law and how it is administered. If you have been injured, you may need an experienced workers' comp lawyer like Cox, Cox, Filo, Camel & Wilson L.L.C. to defend your rights.

Louisiana workers' compensation law pays disability benefits for both temporary and permanent injuries. In most cases, benefits equal two-thirds of the employee's average weekly wages. In permanent, total disability, benefits may be paid for life.

The law is supposed to protect workers, but it often wrongly denies benefits. Oftentimes, workers need an experienced workers' comp attorney like Cox, Cox, Filo, Camel & Wilson to stand by them and insist that proper compensation is made.







As we age, we hope we can avoid major tragedies. But sometimes we're dealt a hand that changes our lives forever- a catastrophic injury. In some cases, wounds heal, bodies and minds mend, and the once devastating event becomes something that made you stronger.

### Types of Catastrophic Injuries

# CLASS ACTION / MASS TORTS

A class action lawsuit is a claim filed on behalf of a group of people who were harmed because of a specific situation they were put in or a product they were exposed to, such as becoming ill from asbestos exposure on job sites. Class action lawsuits can be powerful agents of needed change in company policies, especially with corporations that regularly put their employees at risk. Mass Torts are processed differently, and are primarily lawsuits brought by a large group of people who were harmed on a larger scale, such as an oil spill or defective medication.

A mass tort is a lawsuit in which multiple plaintiffs band together to sue a corporate defendant. Mass torts are the kind you hear about in the wake of a destructive storm, an environmental spill, or a product that injures a number of people. They also arise from instances of occupational exposure. Most toxic tort cases have arisen either from people harmed by using pharmaceutical drugs or by exposure to occupational hazards, like asbestos.

Everyone in the United States who works also contributes to Social Security. The money goes into one fund and is granted to individuals who are either unable to work due to a debilitating medical condition or who have reached an age where working is no longer possible. These funds go a long way towards improving the quality of life for those with disabilities or those who have been seriously injured.

### **SSDI and SSI: What's the Difference?**

By the Social Security Administration's standards, any physical or mental condition that prevents you from being gainfully employed can be classified as a disability. If your disability is one that is long-term or permanent, there are two programs run by the SSA that might be able to help: Social Security Disability Insurance (SSDI) and Supplemental Security Income (SSI).

**Social Security Disability Insurance (SSDI)** only applies to workers who have been working for at least 5 out of the last 10 years before you were disabled.

**Supplemental Security Income (SSI)** is managed both by your state's government and the Social Security Administration. Its purpose is to provide financial aid to disabled and elderly individuals who have little or no income and few assets. Remember that SSI laws vary state to state. Spend time doing some research into your state's specific SSI rules and laws.

The rules for granting Social Security Disability Benefits are strict. Only 30% of all claims that are submitted get approved. If you're denied, you have two choices: appeal the denial decision or give up, and find another option. The appeals process is where things can start to get a little more complicated. This process can be long, and is often one best handled by a Social Security Disability Claims Attorney who is familiar with both Federal and Louisiana Law. # OFFSHORE & MARITIME

The life of a maritime worker can be treacherous. Workers on offshore oil rigs, natural gas wells, and support vessels face harsh conditions and are often far from first responders and other emergency services.

Offshore and maritime positions are among the most dangerous in the world, but they're an important part of Louisiana's culture and economy. Our experienced maritime accident lawyers understand the relevant laws and state statutes that protect Louisiana's maritime workers.

## **Occupational Hazards and Louisiana Workers**

A maritime accident can be devastating to an individual and his or her family. According to a report conducted by the Centers for Disease Control and Prevention (CDC), onshore and offshore oil and gas extraction industries have a collective fatality rate seven times higher than all other U.S. workers.

According to the most recent maritime accident statistics, between 2003 and 2010, 128 maritime workers were killed in activities related to offshore oil and gas operations. Many of these deaths were transportation related, often involving an aircraft; all but one of these fatalities occurred near Louisiana in the Gulf of Mexico.

i. Maritime law, or admiralty law, is a broad legal term used to describe a body of regulations that govern U.S. and international contracts, torts, injuries, and offenses that occur on the water. Maritime workers are protected by general maritime law, which includes provisions such as maintenance and cure, personal injury, and piracy.

ii. In the event a fellow crew member or ship owner is the cause of an accident, the Jones Act enables a seaman, or his surviving spouse or dependents, to peruse a claim against the employer or vessel owner. The Jones Act, historically known as the Merchant Marine Act of 1920, is a U.S. federal statute that allows seamen to sue their employer for negligence damages.







# VERDICTS & SETTLEMENTS

- Multiple cases of class action settlements for Hospital bill pay litigation against bill Review Company totaling over \$338 Million dollars.
- \$3.75 Million for on the job injury: oil field worker injured on the job sustaining numerous broken bones after being crushed by a load weighing several thousand pounds, which fell from a forklift.
- \$10.8 Million Dollar Jury verdict: hired by a woman who was rear-ended by a delivery truck driver. Our client suffered spinal cord injury, paraplegia, and other catastrophic injuries because of the accident.
